## 4. First-aid measures

### Inhalation

Move to fresh air. Oxygen or artificial respiration if needed. Do not use mouth-to-mouth method if victim inhaled the substance. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Call a physician or poison control center immediately.

### Skin contact

Wash the skin immediately with soap and water. Get medical attention if irritation develops and persists. Wash clothing separately before reuse.

### Eye contact

Do not rub eyes. Rinse with water. Continue rinsing. Get medical attention if irritation develops and persists.

### Ingestion

**6. Accidental release measures**

**Personal precautions, protective equipment and emergency procedures**

Immediately evacuate personnel to safe areas. Keep unnecessary personnel away. In case of spills, beware of slippery floors and surfaces. Wear appropriate protective equipment and clothing during clean-up. Do not breathe dust. Use a NIOSH/MSHA approved respirator if there is a risk of exposure to dust/fume at levels exceeding the exposure limits. Ensure adequate ventilation. Local authorities should be advised if significant spillages cannot be contained.

**Methods and materials for containment and cleaning up**

Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). The product is immiscible with water and will spread on the water surface. Stop the flow of material, if this is without risk. Absorb in vermiculite, dry sand or earth and place into containers. Collect dust using a vacuum cleaner equipped with HEPA filter.

Large Spills: Wet down with water and dike for later disposal. Shovel the material into waste container. Prevent product from entering drains. Following product recovery, flush area with water.

Small Spills: Sweep up or vacuum up spillage and collect in suitable container for disposal. Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

Never return spills to original containers for re-use.

**Environmental precautions**

## Appropriate engineering controls
