### SECTION 4: First aid measures

#### General information

Take off all contaminated clothing immediately. Contact with combustible material may cause fire. Ensure that medical personnel are aware of the material(s) involved, and take precautions to protect themselves. Wash contaminated clothing before reuse.

#### 4.1. Description of first aid measures

##### Inhalation

Move to fresh air. Call a physician if symptoms develop or persist.

##### Skin contact

IF ON CLOTHING: rinse immediately contaminated clothing and skin with plenty of water before removing clothes. Wash off with soap and water. Get medical attention if irritation develops and persists.

#### 4.2. Most important symptoms and effects, both acute and delayed

Dusts may irritate the respiratory tract, skin and eyes.

#### 4.3. Indication of any immediate medical attention and special treatment needed

### SECTION 5: Firefighting measures

#### General fire hazards

May intensify fire; oxidiser. Contact with combustible material may cause fire.

#### 5.1. Extinguishing media

##### Suitable extinguishing media

Water fog. Foam. Dry chemical powder. Carbon dioxide (CO<sub>2</sub>).

##### Unsuitable extinguishing media

Do not use water jet as an extinguisher, as this will spread the fire.

#### 5.2. Special hazards arising from the substance or mixture

Greatly increases the burning rate of combustible materials. Containers may explode when heated. During fire, gases hazardous to health may be formed.

### 5.3. Advice for firefighters

#### Special protective equipment for firefighters

Self-contained breathing apparatus and full protective clothing must be worn in case of fire.

#### Special firefighting procedures

In case of fire and/or explosion do not breathe fumes. Move containers from fire area if you can do so without risk. Use water spray to cool unopened containers.

#### Specific methods

Cool containers exposed to flames with water until well after the fire is out.

## SECTION 6: Accidental release measures

### 6.1. Personal precautions, protective equipment and emergency procedures

#### For non-emergency personnel

Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Keep away from clothing and other combustible materials. Wear appropriate protective equipment and clothing during clean-up. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ensure adequate ventilation. Local authorities should be advised if significant spillages cannot be contained. For personal protection, see section 8 of the SDS.

#### For emergency responders

Keep unnecessary personnel away. Use personal protection recommended in Section 8 of the SDS.

### 6.2. Environmental precautions

Avoid discharge into drains, water courses or onto the ground.

### 6.3. Methods and material for containment and cleaning up

Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Keep combustibles (wood, paper, oil etc) away from spilled material. Ventilate the contaminated area. Minimise dust generation and accumulation. Avoid the generation of dusts during clean-up. Collect dust using a vacuum cleaner equipped with HEPA filter. Wear appropriate protective equipment and clothing during clean-up. Stop the flow of material, if this is without risk.

Large Spills: Wet down with water and dike for later disposal. Shovel the material into waste container. Following product recovery, flush area with water.

Small Spills: Sweep up or vacuum up spillage and collect in suitable container for disposal.

Never return spills to original containers for re-use.

## SECTION 7: Handling and storage

### 7.1. Precautions for safe handling

Minimise dust generation and accumulation. Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Keep away from heat. Provide appropriate exhaust ventilation at places where dust is formed. Take any precaution to avoid mixing with combustibles. Keep away from clothing and other combustible materials. Avoid prolonged exposure. Wear appropriate personal protective equipment. Observe good industrial hygiene practices.
