7. Handling and storage

Precautions for safe handling

Do not allow contact with air. Open container carefully and only in a dry, oxygen-free or inert atmosphere. Keep away from any possible contact with water, because of violent reaction and possible flash fire. Handle under inert gas. Keep away from heat/sparks/open flames/hot surfaces. - No smoking. Avoid prolonged exposure. Provide adequate ventilation. Wear appropriate personal protective equipment. Avoid release to the environment. Observe good industrial hygiene practices.

Never allow product to get in contact with water during storage. Keep away from heat, sparks and open flame. Store in original tightly closed container. Store in a dry place. Store away from incompatible materials (see Section 10 of the SDS).
