### 4. First-aid measures

<b>Inhalation</b>	Move to fresh air. Call a physician if symptoms develop or persist. Move into fresh air and keep at rest. If breathing has stopped, perform artificial respiration and obtain medical help. Consult a physician for specific advice.

## 6. Accidental release measures

**Methods and materials for containment and cleaning up** Ventilate the area.

Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Absorb in vermiculite, dry sand or earth and place into containers. Following product recovery, flush area with water.

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

Never return spills to original containers for re-use. For waste disposal, see section 13 of the SDS.

**Environmental precautions** Avoid discharge into drains, water courses or onto the ground. The product should not be dumped in nature but collected and delivered according to agreement with the local authorities.
