SECTION 4: First aid measures

General information

In case of shortness of breath, give oxygen. IF exposed or concerned: Get medical advice/attention. Keep victim under observation. Keep victim warm.

4.1. Description of first aid measures

Inhalation

Remove victim to fresh air and keep at rest in a position comfortable for breathing. Oxygen or artificial respiration if needed. Do not use mouth-to-mouth method if victim inhaled the substance. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Call a POISON CENTRE or doctor/physician.

Skin contact

Remove and isolate contaminated clothing and shoes. Wash off with warm water and soap. Get medical attention if irritation develops and persists. For minor skin contact, avoid spreading material on unaffected skin.

Eye contact Do not rub eyes. Immediately flush eyes with plenty of water for at least 15 minutes. Continue rinsing. Get medical attention if irritation develops and persists.

Ingestion Call a physician or poison control centre immediately. Rinse mouth thoroughly. Do not induce vomiting without advice from poison control center. If vomiting occurs, keep head low so that stomach content doesn't get into the lungs. Do not use mouth-to-mouth method if victim ingested the substance. SECTION 6: Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures
