## SECTION 4: First aid measures

#### General information

#### 4.1. Description of first aid measures

#### 4.2. Most important symptoms and effects, both acute and delayed

Nausea. Prolonged exposure may cause chronic effects.

#### 4.3. Indication of any immediate medical attention and special treatment needed

### SECTION 6: Accidental release measures

#### 6.1. Personal precautions, protective equipment and emergency procedures

#### 6.2. Environmental precautions

#### 6.3. Methods and material for containment and cleaning up

Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Prevent entry into waterways, sewer, basements or confined areas. Stop the flow of material, if this is without risk.

Large Spills: Wet down with water and dike for later disposal. Absorb in vermiculite, dry sand or earth and place into containers. Shovel the material into waste container. Following product recovery, flush area with water.

Small Spills: Sweep up or vacuum up spillage and collect in suitable container for disposal. Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

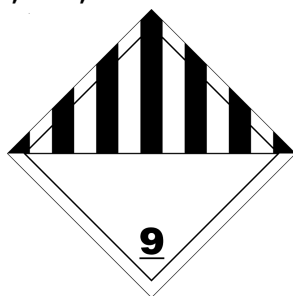

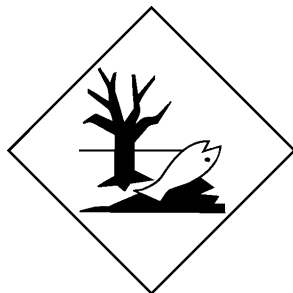
